FIRST AID

GENERAL INFORMATION

COMPOUND is a low-use-rate, low odor activator adjuvant designed to maximize the performance of tank mixes applied to turf and ornamentals. COMPOUND effectively buffers spray solutions, maximizes spread, enhances plant cuticle and cell wall penetration and reduces the off-target movement of tank mix partners.

DIRECTIONS FOR USE

FOR USE WITH PESTICIDES REGISTERED FOR TURF, ORNAMENTALS AND OTHER APPROPRIATE USES.

USE RATES

Apply COMPOUND at 1-3 pints (473 mL-1.42 L) per 100 gallons of spray solution (0.125%-0.375% v/v).

MIXING INSTRUCTIONS

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. **Do not** mix with other products in a mixing vessel or inductor. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP)
3. Dry soluble and suspension fertilizers / micronutrients
4. Flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Keep container closed tightly when not in use. Prevent water from being introduced into the contents of this container. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
