Apply to dry turf and water in as needed. Remove fertilizer from non-target areas such as driveways, sidewalks and hardscapes.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn.

Maryland application: The product is being used in accordance with the recommended application rates established by the University of Maryland.

In NH: Do not exceed 0.7 lb. soluble nitrogen per 1000 sq. ft. per application. Do not exceed 0.9 lb. total nitrogen per 1000 sq. ft. per application. Do not exceed 3.25 lbs. total nitrogen per 1000 sq. ft. per application site per year.
