STATEMENT OF PRACTICAL TREATMENT

GENERAL INFORMATION

SYNC is a unique adjuvant technology designed to enhance the performance of both contact and systemic fungicides and lengthen disease control, even when applied in reduced spray carrier volumes.

DIRECTIONS FOR USE

For use with fungicides registered for use on golf courses, sports turf, and residential and commercial lawns.

USE RATES

Apply SYNC at 1 pint (16 fl. oz./473 ml) per 100 gallons (378.5L) or .125% v/v of spray solution.

MIXING INSTRUCTIONS

Always mix this product in accordance with the instructions found on the pesticide label concerning adjuvants. In the absence of specific mixing instructions, fill the spray tank 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order:

1. If foaming is anticipated, use an antifoam/defoamer such as Knockdown™
2. Ammonium sulfate, fertilizers and micronutrients
3. Water-soluble packets, dry flowables and dispersible granule pesticides
4. Flowable pesticides
5. Water-soluble pesticides
6. Emulsifiable concentrate pesticides
7. Continue agitation and finish filling spray tank to desired level
8. Add SYNC to the spray solution and continue agitation
